Neutered/Spayed Dog: \$10.00 • Intact Male/Female Dog: \$15.00

To license your dog(s) by mail, you must send the following items:

- 1) This **completed** form;
- 2) A copy of each dog's **current rabies certificate**; and
- 3) A check for the **appropriate License Fee** made payable to the Town of Eastham.
- 4) You can now register or renew your dog's license through the Town of Eastham's -- "Pay Bills Online" Link at www.eastham-ma.gov.

HOUSEHOLD KENNEL LICENSE: Required when four (4) dogs over the age of six months are owned, kept, harbored, or temporarily cared for. Please complete 2022 Household Kennel License Application and submit with \$50.00 License Fee. 2022 Household Kennel Applications can be obtained at the Town Clerk's Office or online at www.eastham-ma.gov. New applications are subject to approval by the Animal Control Officer.
